 - Objective evidence documentation (one of the following): Utah Driver's license, Utah Voter ID Card, Utah vehicle registration, or evidence of employment in Utah
 - **Signed Declaration of Intent to Establish Permanent Residence in Utah.**
- Immediate family member of a U.S. military veteran who has separated within the last five years.
 - Evidence of veteran's honorable or general discharge (DD 214, Member 4 copy) within the last five years.
 - Objective evidence documentation (one of the following): Utah Driver's license, Utah Voter ID Card, Utah vehicle registration, or evidence of employment in Utah
 - **Signed Declaration of Intent to Establish Permanent Residence in Utah.**
